### Description

This document contains a 20 page list updates to "kaupthing-claims.pdf". That document was released on March 15 by WikiLeaks which details 28167 claims, totaling over 40 billion euro, lodged against the failed Icelandic bank Kaupthing Bank hf. The document is significant because it reveals billions in cash, bonds and other property held with Kaupthing by a vast number of investors and asset holders, including Goldman Sachs, Deutsche Bank, Credit Suisse, Morgan Stanley, Exista, Barclays, Commerzbank AG, etc. It was confidentially made available to claimants by the Kaupthing Winding-up committee.
