It is important that at the very least, 50% of these changes are undertaken by end of Jan 2009 so as to facilitate Part 2 of the strategy. Whatever it takes, Muthaura, Gichangi, Mutua, Ali and

Kianga must leave their respective offices by mid February, 2009 to remove any obstacles for Part Two. As recommended, we have left open the replacements for the security docket.

B. DEMONIZATION OF KIBAKI & PNU
