To Whom It May Concern:

We represent Sigma Phi Epsilon Fraternity, a Virginia non-stock corporation, ("Sig Ep"), and are writing to you on its behalf regarding your unauthorized use of a copyrighted work owned by Sig Ep. Please address all correspondence on this matter to us.

Posted on your website is a link to the secret ritual book of Sig Ep (the "material"). We have enclosed a screenshot of your website showing the posting where the text of the material can be found. This copyrighted material was created by members of Sig Ep and is its sole property.

Sig Ep has invested substantial time, money and effort in creating this material. Your unauthorized posting of this material constitutes copyright infringement. We, on behalf of our client, in good faith assert that the use of the material on your website is not authorized by Sig Ep, the copyright owner, its agents, or the law.

Without waiving any rights that Sig Ep may have against you or those acting in concert with you, we hereby demand that you immediately cease all uses of Sig Ep's copyrighted material, and that you specifically (1) cease and desist any further postings or uses of this material and any other similar material on your website; (2) remove the material, any links to the material, and any similar material from your website.

Please be advised that Sig Ep intends to use any and all remedies available to it in law and equity, including but not limited to litigation against you in order to preserve the integrity of its copyright. Sig Ep's remedies against you for your infringement may include recovery of

We request a response within 5 business days after your receipt of this letter. If we do not hear from you, we may proceed as Sig Ep deems necessary, without further notice to you.

We look forward to your prompt response. The assertions and statements in this notification are accurate, and under penalty of perjury, this firm is authorized to act on behalf of the owner of the exclusive rights holder of the copyrighted material.
